

# **GLOBAL ENVIRONMENT STATEMENT**

Clifford Chance LLP believes that, as a firm, we have a responsibility to work collaboratively with our colleagues and suppliers to reduce the impact of ours (and their) business operations and delivery of services on the environment. We also aim to ensure we are able to respond effectively when our clients' request that we work with them to reduce their impact.

## As a responsible business, we:

- maintain a global environment policy, inclusive of clear targets and objectives, to govern our internal and external approach to reducing our environmental impact;

- reach net zero emissions by FY2050 in accordance with our **SBTi commitment**;
- commit to eco-efficient practices in our operations, which reduce and prevent pollutant emissions;
- enable virtual service delivery and digital collaboration to reduce our business travel;

- make sustainability a material factor in our decisions about the procurement, design, refurbishment, operations and management of our real estate; and seek to conserve natural resources and promote a circular economy;
- purchase energy from renewable sources and tariffs, where appropriate and available;
- measure waste generation and water usage across our operations, and strive to reduce and divert from landfill and segregate waste. This includes educating our employees on proper waste disposal practices;
- source food from local, sustainable and fairtrade sources, where appropriate;
- reduce food waste and packaging in our catering, including removal of single-use plastics, working collaboratively with our suppliers;
- promote reuse and recycling in our offices, including new recycling streams for office waste and re-use and recycling of IT equipment, where applicable; and
- raise awareness of our global environment policy, encouraging active engagement and providing best practice guidance, tools and training to support participation.

- ensure the firm is able to provide our clients with outstanding advice and services to support their sustainability, including in relation to the transition to a low carbon and nature-positive economy;
- explore ways we can work collaboratively with our clients to reduce the environmental footprint of our services;
- ensure we have policies and processes in place to identify, assess, and mitigate against any potential material environmental impacts associated with our mandates.
