A broad range of matters globally

Father-son business battle

Advised the Swiss son and CEO of a global business in a battle with his father to prevent the father revoking a trust and taking back the business for his fifth wife. The father alleged that he had been unduly influenced by his son to create the trust. The matter settled with an all-encompassing family arrangement, with Bermuda Court approval, which addressed the father's entire estate very shortly before his death.

Family Office mediation

Advised successive generations of a family in Asia in relation to the mediated redefinition of their family office, and global assets, avoiding what would otherwise be deeply damaging allegations.

Family business buy out

Advised a Swiss UHNWI buying out his siblings' interests in the family business in return for liquid investments; long, complex but patient negotiations over multiple years concluding with court approval in Cayman.

UK/Indian family fall out

Advised one branch of a well-known UK/Indian family in relation to the transition of their wealth from the older generation to the next with proceedings in London, Switzerland and offshore. Greek Inheritance Restructuring

Polish custody battle

Advising a Polish family involved in a dispute over child custody. Our work has included close collaboration with family law academics, private investigators, and experts, including psychologists.

Dutch divorce

DNA dispute

Conspiracy Claim

Sanctions

Successfully defended ING Bank in proceedings in London in 2025 relating to the application of sanctions. The claimant, EuroChem, is a Russian fertiliser company founded by Andrey Melnichenko, who was sanctioned by the EU in March 2022.

Misleading publication

Successfully defended a news organization in proceedings in the UAE by an UHWNI alleging that he had been falsely accused of unlawfully circumventing sanctions.

Multi-Jurisdictional Trust Restructuring

Advised a corporate trustee in relation to a multi-jurisdictional trust restructuring involving London, Guernsey, BVI and the US and complex valuation issues of a range of trading and other assets.

Breach of Trust
