# This week at the UK regulators

## Thirty second guide: The week in overview

Attention last week seems to have been firmly focused on final preparations for the EU General Data Protection Regulation entering into force (on 25 May). There was relatively little by way of publicised developments from the FCA or PRA. Enforcement developments were confined to a handful of cancellations of permissions and a Decision Notice referred to the Upper Tribunal in respect of alleged integrity and client asset rule breaches by an individual in the consumer credit sector. The only development to emerge from the PRA (and indeed the only policy development from either regulator) was the publication of a consultation paper setting out its approach to securitisation.

#### **Enforcement notices**

On 21 May, the FCA issued a Decision Notice setting out its intention to impose a prohibition order on Mr Darren Newton based upon findings by it that he lacks integrity and has breached client asset rules. The case has been referred to the Upper Tribunal, which may dismiss it or remit it to the FCA with a direction that it reach a decision in accordance with any findings the Tribunal may make.

In separate cases, the FCA has issued Final Notices cancelling the permissions of the following firms and individuals operating in the consumer credit and investment advisory sectors:

- West Gate Car Sales (UK) Limited (25 May)
- Forseti Capital LLP (21 May)
- Premier Management Partners Limited (21 May)
