

THE ANNOUNCEMENT OF THE PRESIDENT OF THE ENERGY REGULATORY OFFICE ON THE TIMETABLE OF RES AUCTIONS PLANNED FOR 2019

On 14 October 2019, the President of the Energy Regulatory Office announced that the draft timetable of auctions for renewable energy sources for 2019, covering the planned dates, volume and value of the energy offered in individual auctions, was presented to the Minister of Energy for approval.

The draft timetable prepared by the President of the Energy Regulatory Office should then be agreed with the Minister of Energy within 14 days. In the event the Minister of Energy does not present any comments to the draft timetable within the said timeframe, the draft timetable will be deemed agreed.

The President of the Energy Regulatory Office will make a separate announcement in relation to each auction no later than 30 days before the commencement thereof.
